The Grenada Citizenship by Investment Unit is delighted to update local agents of the following clarifications to the rules and regulations concerning the processing of application and files. These changes represent a significant enhancement for the Grenada Citizenship by Investment Program.

To ensure the efficient processing of files, the CBI unit will accept the following presentation process:

#### **Step 1**

- 1) Current passport
- 2) Birth certificate
- 3) Second form of picture ID
- 4) Form 2
- 5) Police clearance certificate1)
- 6) Forms 1,2, 5, 6
- 7) Education Certificate (highest Level only)
- 8) Proof of Address
- 9) Marriage / Divorce Certificate)
- 10) Bank Reference
- 11) Proof of Source of Funds

Concurrently with step 1, the following fees must be paid:

Due Diligence Fees  
Application Fees  
Processing Fees

#### **Step 2**

The balance of the required documents will be submitted at this stage

For the avoidance of doubt, an application is only considered to be submitted for processing in accordance with Act No. 15 of 2013 (as amended) once Step 2 is completed.

The Grenada Citizenship by Investment Unit is delighted to update local agents of the following clarifications to the rules and regulations concerning supporting documents. These represent a significant enhancement for the Grenada Citizenship by Investment Program.

The following clarifications will apply to the acceptance of the supporting documents listed below:

Column1	Current	Clarifications
Passport	All Pages (Current & Expired)	All pages of current passport and Visas
Passport Photo	Required	No Changes
National ID	National ID	Other Government-issued Picture ID for those without National ID is accepted
Visas	Current and Expired visas	Current visas
Address Confirmation/Utility Bill	Utility Bills	Confirmation letter from landlord or property management company is also acceptable
Birth Certificate	Birth Certificate / Household Register for Chinese Nationals	Family Book/ Individual civil status document for Arab families



## GRENADA CITIZENSHIP BY INVESTMENT

Police Certificate	Police certificate	When multiple jurisdictions are involved, and police certificates cannot be provided affidavit of no criminal record is acceptable providing the applicant has submitted the Police certificate of the current resident country.
School Certificate	Secondary Education & Above	Only the Highest Education Obtained post-secondary is required
Marriage Certificate (if applicable)	Marriage certificate	Family Book for Arab families is accepted
Reference Letter	Required and should be addressed to "CEO of Grenada, CBI"	<b>May also be addressed to "whom it may concern"</b>
Letter of Employment (if employed)	Required and should be addressed to "CEO of Grenada, CBI"	<b>May also be addressed to "whom it may concern"</b>
Bank Letter	Required and should be addressed to "CEO of Grenada, CBI"	<b>May also be addressed "to whom it may concern". As an alternative, personal credibility report or certificate of deposit are required</b>



## GRENADA CITIZENSHIP BY INVESTMENT

- ✚ Current Passport only requires one certification stamp.
- ✚ All Current Visas which fall outside current Passport must be certified separately
- ✚ Please note all documents and letters must be addressed “to Whom it may concern” or to the Grenada Citizenship by Investment. Documents addressed to another jurisdiction will not be accepted.
