- 1.4 Originating from the Republic of North Macedonia (emigrant)
- 1.5 National or other special interest
- 1.6 Recognized refugee or stateless
- 1.7 Person under 18 years of age if one or both parents have acquired citizenship of the Republic of North Macedonia by naturalization

## INSTRUCTIONS FOR FILLING THE APPLICATION FOR ACQUISITION OF CITIZENSHIP OF THE REPUBLIC OF NORTH MACEDONIA

- The data from part 1 is filled in by the applicant
- Data from section 2 and 3 shall be completed if the application for citizenship of the Republic of North Macedonia applies to the spouse or children of the applicant
- In part 3 marked for signature are signed the adult children, but the children who have reached 15 (fifteen) years of life, only for the procedure under ordinal number 1.7 that they agree to acquire citizenship.
- Sections 1 and 2 marked as contact person and address in the Republic of North Macedonia are filled in for the procedures under ordinal number: 1.3; 1.4 and 1.5
- The applicant chooses the way in which the Ministry of Interior will be able to contact him (by phone or electronically). The selected method of contact is listed in the section \* contact details \*
- If during the procedure there is a need to obtain the documents listed in section 4, the applicant will be additionally notified to attach them to the application.
