*What is the legal basis on which citizenship is granted?*

GCAP offers an exclusive second citizenship program for the country of México - endorsed by the Immigration Department of México.

Generally as a foreigner born abroad, it takes 6 years to acquire México citizenship, through residency.

Via our program, you will be naturalized as a citizen of México in 14/20 days, by:

1. Past Residency

2. Descent

\*This is what will be registered in the system by the Immigration Department of México

*Can the Documents be delivered to UAE, China, Russia?*

GCAP offers 2 options, your passport & other documents can be sent to you, by secure and recorded courier, globally. Or you can pick them up from our team in México, or the USA.

*Can my name be amended?*

# PROCESS OF OUR MÉXICO CITIZENSHIP BY INVESTMENT PROGRAM

## 01

### Submit Required Information For Pre-Approval

- Clear copy of the first page of your current passport, the Immigration Department of México will use your passport copy to conduct 2 background checks (1 in México, and 1 globally via. Interpol database)

\*Pre-Approval is completed within a maximum of 24hrs after submission to the immigration department of México (Timeframe is an estimate based on our past experience and best practice)

## 02

### Submit Required Information For Citizenship Processing

- 3 Separate passport photo copies (1 for Drivers License, 1 for Passport, 1 for Certificate of Naturalization)
- Blood type
- Emergency contact number (it must be a México number, this is optional, we can provide this)
- Information about your parents (mother & fathers name, date of birth/place of birth, mothers maiden name)
- 2 Signature copies, with blue ink (1 for Passport, 1 for Drivers License)
- Fingerprints copies, of both hands.

## 03

### Invoice

GCAP Accepts:  
-International Bank Transfer  
-Crypto (USDT)  
-Cash (USD)

\*The program fee is required to be paid, upon completion of Pre-Approval. Optionally - GCAP can provide an agreement, jurisdictional in the USA.

## 04

### Approval

You will be Processed/Naturalized as a Citizen of México in 14-20 days, by the immigration department of México.

GCAP will send you a video file of your passport being scanned in the system, once you have this video, you can verify your documents with an official government website of México [<https://www.gob.mx/curp>].

GCAP offers 2 options:

1. Your passport and other documents can be sent to you by secure and recorded courier, anywhere in the world.
2. You can pickup your documents from our team in México, or our team in the USA.
